TAN Card Details Tax Deduction Account Number or Tax Collection Account Number which is a 10-digit alphanumeric number. The number which is issued by the Income Tax Department is required to be obtained by all persons who are responsible for collecting tax at source (TCS) or for deducting tax at source (TDS).
